will be picked up:

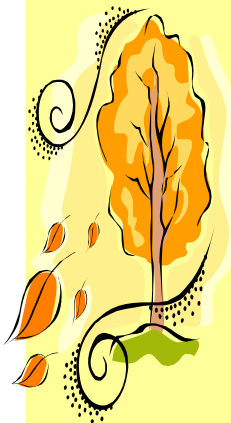
Wednesday, November 21 and Friday, November 23

Trash cans cannot weigh more than 55 lbs total (including the trash can). **DO NOT PUT PUMPKINS IN THE TRASH CANS.**



Leaf pickup will begin soon. We will be around on a continuous basis. Leaves should be placed along the curb, **NOT IN THE ROAD** and **SHOULD NOT** be put in bags or other containers. **PLEASE DO NOT MIX ROCKS AND/OR BRANCHES WITH THE LEAVES AND DO NOT PLACE LEAVES ON OR NEAR THE STORM BASINS.**



Brush pickup will continue, and we request that you be patient since the crews will also be busy picking up leaves.

please do not put it in the road.



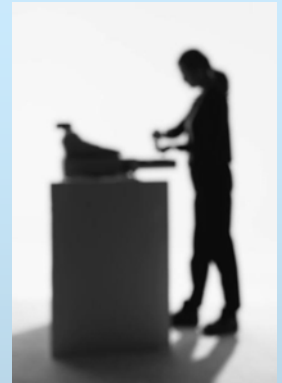

The Town of Manlius Police Department is scheduled for an on-site assessment as part of a program to achieve re-accreditation by verifying it meets professional standards.

Administered by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA), the accreditation program requires agencies to comply with state-of-the-art standards in four basic areas: policy and procedure, administration, operations, and support services.

As part of the on-site assessment, agency employees and members of the community are invited to offer comments at a public information session Monday December 10th, 2007 at 7:00 p.m. The session will be conducted at the Village of Manlius Village Centre, 1 Arkie Albanese Avenue, Manlius New York.

Agency employees and the public are also invited to offer comments by calling 682-1195 on Tuesday December 11th, 2007 between the hours of 1:00 p.m. and 5:00 p.m. Comments will be taken by the assessment team.

Telephone comments as well as appearances at the public information session are limited to ten minutes and must address the agency's ability to comply with CALEA standards. 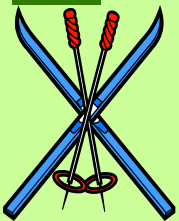

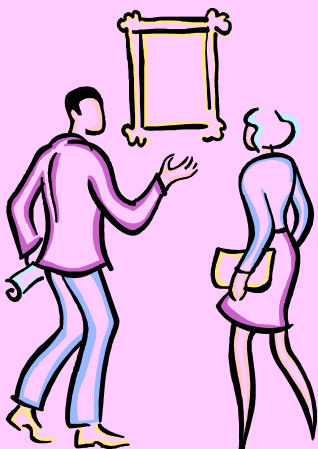
