Chicken Permit Application

Village Code - Chapter 65-4:

It shall be unlawful for any person in the Village to keep or suffer to be kept any domestic animals, except dogs and cats (see Article III.), farm animals, poultry, other animals, and exotic animals, wherever located in the Village, unless such person shall first obtain a license from the State of New York or the Town of Manlius and a written permit so to do from the Village Board of Trustees. The fee for such permit shall be established by the Village Board of Trustees.

PROCEDURE

Submit the following required items with your completed application:

- ✓ **Complete all applicable sections of the Chicken Permit Application.**
 - ✓ **Copy of enclosure layout and property survey showing proposed location.**
 - ✓ **All applicable parties must provide their notarized signatures on the application.**
 - ✓ **Payment for processing must be received with application.**

- A) An application is considered complete once all applicable required items have been received. The permit application will be added to the next Board of Trustees meeting agenda.**
 - B) Applicant must be present at time of Board of Trustees review.**
 - C) Board of Trustees will review application and approve or deny.**
 - D) Formal written notification of approval/denial will be sent to applicant via postal mail within one week of Board of Trustees determination.**
 - E) If approved, permit will take the form of a letter from Board of Trustees. Permits are non-transferable.**
 - F) Permits shall be revocable at any time by the Board of Trustees.**

Guidelines for Enclosures

All poultry shall be kept outside of the dwelling in an enclosure which shall include a coop and a pen/run which will allow for an indoor space (coop) to roost at night and an outdoor area (pen/run) for daytime use and exposure to fresh air and sunshine. The poultry enclosure shall be maintained in a clean, dry, odor-free manor at all times. All manure, uneaten feed, and other trash shall be regularly removed and properly disposed so the poultry enclosure does not constitute a nuisance, safety hazard or health problem.

- a) The poultry enclosure shall be secure to prevent the entry of rodents and predators, and shall effectively contain and protect poultry.
- b) The poultry coop shall be constructed of solid material on all sides, including roof and door(s). Vents, covered with wire, shall be placed as necessary for adequate ventilation.
- c) The coop must have roosting bars for poultry to perch and sleep on.
- d) The coop and pen/run shall provide adequate area per animal and access to fresh water at all times.

- e) The pen/run shall be connected to the coop, consist of traditional building or fencing material and shall be covered by wire, netting or solid building material. The pen/run shall provide exposure to both sun and shade.
- f) Poultry may be allowed to "freely roam" outside their enclosure if they do not leave the property. This can likely be successful if the property has fences of adequate height.
- g) The coop and pen/run shall be constructed and maintained in a workmanlike manor comparable to that of accessory structures
