## Dear Residents,

Fall in the village is so beautiful. This year is no exception, minus all the rain. This past summer we finished several projects as well as finalizing some other very important ones. First I want to thank all the dedicated employees for keeping the village looking so great as well as our volunteers who dedicate their time and talents for the betterment of our village. We are truly lucky to have so many great people helping make our village the best it can be. I'd like to recognize our DPW & Fire services for their efforts during last two rainstorms where we had over 6-inches of rain and they were out both days, and into the nights, making sure we had as little damage as possible. It's a comfort knowing they are in our village to help us when events like this happen.

As for projects, we are finishing up on speed humps on Warren Street and South Burdick. These requests came from concerned residents and the board felt that this was a good solution to the speeding problems in this area. And the **Bishops Brook project is almost done**. The stream banks have been repaired and redone, the knee walls have been treated with the new stone façade and the pavement has been replaced. The guard rails have been ordered and are in so we are just waiting for the contractor to install. The Limestone Creek project is on pace to be finished in a few weeks barring any more rain. Every time it rains it has set the contractor back a few days. If you haven't had a chance please go down behind the town hall and see what we have been working on. When

we are done the creek will flow better, we will have areas for fishing and the great part is the trout will have a place to spawn. We also **will have the breach in Canal Landing park fixed**. This project was a grant award from the NYS DEC Clean Water Initiative as well as Assemblyman Stripe and Senator Mannion. This park has turned out to be a real asset to the village and this project is another example of how important this is to our residents and neighbors.

This year again we are **only picking up leaves during the month of November** (in addition to the regular trash & recycling pickup). We tried this last year and it worked out very well. In December we will continue with the normal brush, C&D, hard fill pickup schedule. Garbage & recycling is not affected by this change. Please remember that when they come around it may take them a few weeks to get back to you depending on how fast the leaves are falling. I think residents would be interested in knowing that some years we spend more taxpayers' dollars on leaf pickup than we do on snow removal. I'd like to express gratitude to T.H. Kinsella's for taking all our leaves and not charging the village; they are a true partner of the village and I want to thank them.

We recently got a **grant from Onondaga County American Rescue Plan**. One part of the grant is to tear down the properties on Feeder Street to make way for a park. This park project is in the design/grant award phase. I hope in the next newsletter to let you know if we get the grant. If we do, we will be hosting public hearings with the residents to show you the draft plans. The other part is a planning grant to see if we can add senior housing units at the senior center complex. This conceptual plan is just that conceptual, nothing will be done until we meet with all involved to see if it can even be accomplished and if it can fit into the character of the neighborhood and senior center complex. Our goal is to continue to be a vibrant and good neighbor to everyone that uses the senior center or lives near it.

We are working on next year's goals and plans as we slowly adapt to the new reality of Covid and the pandemic. Every day I am working with department heads, Trustees, and residents on how we can come out of this pandemic stronger while being the best village possible. To this end **we have hired EDR to update our comprehensive plan**. This plan is vital to our village's future, as well as grant opportunities. We have formed a steering committee, and we will be adding a village website page for this plan. We are still in the early stages but please look for more information. Your input is vital to the success of this program so keep your eye out for workshops and public hearings in the future. My hope is to have this completed in the next year.

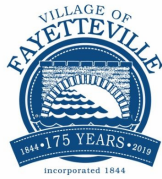
As you can see there is a fair amount being done as I write this newsletter. I can't believe all the work we can get accomplished when we work together for the betterment of our residents. I love working day in

## Comprehensive Plan Update

Village of Fayetteville Mayor Mark Olson is excited to announce the kick-off of the 2021 Comprehensive Plan update. The Village of Fayetteville last updated its Comprehensive Plan in 2014, marking almost 10 years since the community engaged in the planning process.

Through the Comprehensive Planning process, the Village will review the 2014 vision, goals, and strategies in the context of current and emerging trends, challenges, and opportunities. Topics to be explored through this process may include housing, adaptive re-use of existing structures and sites, transportation, connectivity, parks and recreation, and community design.

“Fayetteville has an opportunity to revisit the direction of our community to make it an even better place to live, work, shop, and recreate,” said Olson. “We look forward to working together to identify specific strategies centered around a unified vision.”

The planning process commenced in early October with an anticipated completion date of September 2022. The Village Trustees established a 7-member Steering Committee who will champion the project. “The Steering Committee represents a diverse group of citizens who bring a wealth of insight and knowledge to the planning process,” said Village Trustee Mike Small. “Their leadership in this process will help ensure the updated plan is truly reflective of Fayetteville and the needs of the greater community.”

A critical piece of the planning process is ensuring that members from the community are actively engaged from project initiation through completion, and implementation. With assistance from the planning consultant team, Environmental Design Research (EDR), the Village will be soliciting community feedback through a range of community engagement activities including public meetings, workshops, and focus groups. The Village will actively update its website [www.fayettevilleny.gov](http://www.fayettevilleny.gov) and social media channels to keep residents informed on the process and upcoming events.

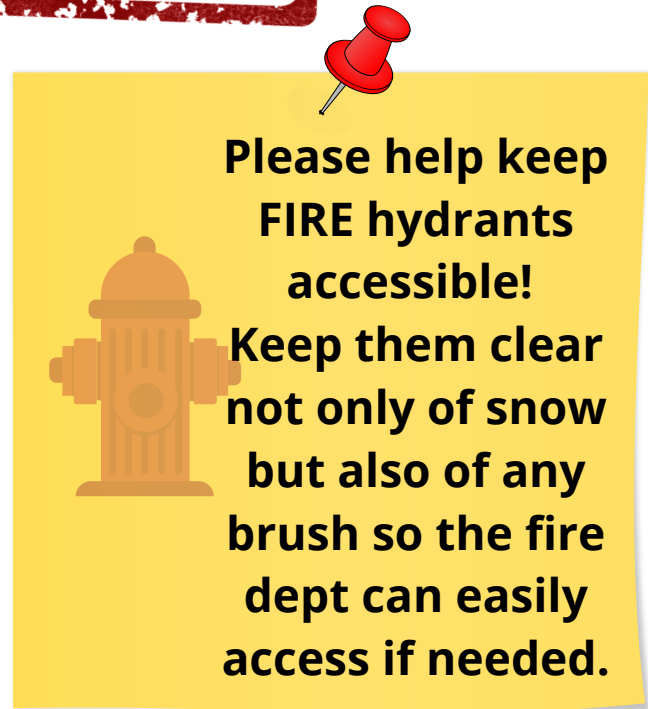
